### Segment Two Course Provisions

1. Macatawa Driving School will provide a minimum of six (6) hours of classroom instruction and shall not exceed 2 hours of instruction per day.
2. Macatawa Driving School will supply all materials for the class.
3. Students must maintain a "C" average on all assignments. Students must also achieve 70% correct answers on the State Test.
4. Upon completion of the course, the student will be issued a "MICHIGAN DRIVER EDUCATION CERTIFICATE OF COMPLETION" attesting to his/her completion of the requirements for the certificate.

### Terms

For a student to participate in Segment 2 class, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a Level 1 license, which has been held for not less than 3 continuous months. The parent or legal guardian agrees to pay the fee of \$75.00 prior to or on the first night of class if the student took Segment 1 through Macatawa Driving School, or \$100.00 if Segment 1 was taken elsewhere. We will accept cash, checks, money orders or credit card payments (credit card payable online or by phone). The student is only guaranteed a position in the class when a payment is received prior to the class starting time. There is a \$25.00 charge for all returned checks. There will be a nominal administrative fee for any certificate that needs to be reissued for any reason including damage or loss.

### Refund/Make-up Policy

If for any reason you decide to withdraw from the course, there will be no refund. Due to the short nature of Segment Two class time, no absences will be permitted. Any absence will result in dismissal from class with no refund. We may be able to switch you to another session if notified before the start of the session.
